An applicant has <u>60 days</u> from the date stated on the Department of Health Care Services' (Department/DHCS) notice of claim to submit an Application. All of the information requested in the Application is voluntary; however, failure to provide accurate documentation to substantiate hardship may result in a denial of the Application. A signature is required to process an Application. It is not necessary for the applicant to submit documentation previously received by the Department. The Department reserves the right to request additional documentation.

A substantial hardship shall not exist when the decedent or applicant created the hardship by using estate planning methods to divert or shelter assets in order to avoid estate recovery.

• A denial letter from a financial institution (a bank, savings and loan, credit union, etc.) for the applicant's share of the claim or the applicant's share of the estate, whichever is less.
